AMH2035 | Recent American History Since 1945 | 3.00 credits

The internal development of the United States and the role of the U.S. in world affairs since World War II.

Course Competencies:

3. Assessing major historical events' historical and contemporary implications on the United States' domestic policies and international relations, correlating them to the nation's evolving role in global affairs
