## **Purpose:**

To outline the process and expectations for students assigned an Incomplete ("I") in NUR 2960: Senior Seminar, ensuring timely course completion and compliance with graduation and licensure requirements.

## **Policy Statement:**

A student who receives a grade of "I" in NUR 2960 must complete all assigned course requirements by the end of the next major term (Fall or Spring) to convert the "I" grade to a letter grade. Failure to complete the requirements by the deadline will result in an automatic assignment of an "F."

#### **Procedure:**

# 1. Grade Change Deadline:

- Students must complete all outstanding coursework by the posted deadline.
- The instructor must submit a completed Grade Change Form and Incomplete Contract (signed by student and instructor) to the Admissions and Registration Office before the end of the next major term (Fall or Spring).

## 2. Graduation and Licensure Notification Delay:

- Students with an "I" in NUR 2960 will not be eligible for graduation until the incomplete grade is resolved with a passing letter grade.
- Graduation will not be retroactively applied to a prior term. The degree will be conferred at the end of the semester in which all requirements are met.
- Graduation will be deferred to the end of the semester in which all requirements are completed, and the final grade is posted.
- Students' names will be submitted to the Florida Board of Nursing only after graduation has been officially processed, which occurs at the end of the semester in which all requirements are completed.

## 3. Course Repeat Restriction:

- Students may not register for NUR 2960 again until a final grade (A, B, C, D, F, S, P, or U) has been officially posted.
- To complete NUR 2960, students are required to enroll in and complete an approved NCLEX review course, including all associated modules, assignments, and assessments of the review course.
- Additionally, students must submit proof of completion to the faculty of record.
- Students also must achieve ATI Virtual ATI "Greenlight" status.
- Students must maintain access to Virtual ATI (VATI) until "Greenlight" is achieved. If access to ATI expires, the student is responsible for any renewal fees.

#### Responsibilities

# **Faculty Responsibility**

It is the responsibility of the course faculty to:

- Monitor student progress toward completion of assigned requirements.
- Maintain regular communication with students regarding outstanding assignments and deadlines.
- Submit the completed Grade Change Form and Incomplete Contract to the Admissions and Registration Office once all requirements have been met.

## **Student Responsibility**

Students are responsible for:

- Completing all assigned coursework and NCLEX review requirements by the established deadline.
- Maintaining communication with faculty and responding promptly to any followup requests.
- Ensuring that ATI "Greenlight" is achieved and verified prior to the submission of the grade change.
- Covering any renewal costs for VATI access if necessary.

## **Chair Responsibility**

The Department Chair is responsible for:

- Assisting in the oversight of incomplete grade follow-ups and ensuring compliance with institutional policies.
- Confirming that graduation processing is aligned with the completion of course and licensure eligibility requirements.
